G.S.R. 198.—In exercise of powers conferred by the proviso to Article 309 of the Constitution and in supersession of the—

- (i) Safdarjung Hospital (Class-III posts) Recruitment Rules, 1973, in so far as they relate to the posts of Nursing Sister and Staff Nurses;
- (ii) Willingdon Hospital and Nursing Home (Class III posts) Recruitment Rules, 1973, in so far as they relate to the posts of Nursing Sister and Staff Nurse;
- (iii) Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital, New Delhi (Group 'C' posts) Recruitment Rules, 1981, in so far as they relate to the posts of Nursing Sister and Staff Nurse;
- (iv) Malawati Saran Children's Hospital, New Delhi (Group 'C' posts) Recruitment Rules, 1981, in so far as they relate to the posts of Nursing Sister and Staff Nurse;
- (v) Pondicherry Medical College|Jawaharlal Institute of Post-Graduate Medical Education and Research, Pondicherry (Recruitment to Class III posts—Nursing Staff) Rules, 1963, in so far as they relate to the posts of Nursing Sister and Staff Nurse.

except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Nursing Sister and Staff Nurse in Safdarjung Hospital|Dr. Ram Manohar Lohia Hospital|Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital|Kalawati Saran Children's Hospital|Jawaharlal Institute of Post-

Graduate Medical Education and Research, Pondicherry, namely :—

1. Short title and commencement.—(1) These rules may be called the Safdarjung Hospital|Dr. Ram Manohar Lohia Hospital|Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital|Kalawati Saran Education and Research, Pondicherry (Nursing Sister and Staff Nurse) Recruitment Rules, 1997.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and scale of pay.—The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications etc.—The method of the recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 14 of the said Schedule.

- 4. Disqualification.—No person,—
 - (a) who has entered into or contracted marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.

Saving.—Nothing in these rules shall affect relaxations, relaxation of age limit and other conditions required to be provided for the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
