**ADDENDUM**

Following clarifications are hereby issued for information of all prospective bidders in r/o **Tender ID. 2025\_VMMC\_855553\_1:**

**1. Defect Liability Period (DLP):**

The Defect Liability Period (DLP) for the works and services under the project shall be **02 (Two) years** from the certified date of completion and handing over.

The DLP shall include all components executed under the contract, including but not limited to:

- Civil and Structural Works
- Electrical Systems
- Plumbing and Sanitary Installation
- Fire Detection and Fire Safety Systems
- LAN and Networking Infrastructure
- HVAC, Lifts, and any other mechanical or electromechanical installations.

**2. Integrity Pact - Undertaking Letter:**

All bidders are required to submit an undertaking letter on their letter head along with their bids, confirming their **agreement and commitment to abide by the Integrity Pact** as detailed in the EoI cum RfP document.

The format of the Undertaking Letter is attached with this Addendum as Annexure-1.

**3. Format of Bank Guarantee for Bid Security:**

A prescribed format for submission of the **Bank Guarantee** for Bid Security (EMD) is enclosed with this addendum as Annexure-2.

Bidders shall strictly use this format for submission of BG towards Bid Security.

**This addendum shall form an integral part of the tender document and must be signed and submitted along with the bid documents.**

- (2) If the Bidder having been notified of the acceptance of his Bid by the Medical Superintendent, VMMC & Safdarjung Hospital during the period of bid validity; including the period of 45 days beyond the period of bid validity;
  - a. Fails or refuses to execute the Contract/MoU in accordance with the instructions in EoI cum RfP document (including Amendments/Addendum issued), or
  - b. Fails or refuses to furnish the Performance Guarantee, in accordance with the instructions in EoI cum RfP document, or
  - c. Does not accept the correction of the Bid Price.

We undertake to pay to the Medical Superintendent, VMMC & Safdarjung Hospital up to the above amount upon receipt of his first written demand, without the Medical Superintendent, VMMC & Safdarjung Hospital having to substantiate his demand, provided that in his demand the Medical Superintendent, VMMC & Safdarjung Hospital will note that the amount claimed by him is due to him owing to the occurrence of one or any of the four conditions, specifying the occurred condition or conditions.

This Guarantee will remain in full force up to 135 days after the deadline for submission of Bids as such deadline stated in the EoI cum RfP document (or Amendment/Addendum issued thereto).
