They should submit the following documents in original at the time of admission to authorities along with one set of self attested copies as per the guidelines issued in information bulletin (NEET SS) for the admission session 2024.

1. Seat Allotment Letter issued by MCC.

2. Admit Card issued by NBEMS in original, NEET Score Card / Rank Letter

3. Identity proof copy (Adhar card/Driving Lesence).

- 4. 10<sup>th</sup> & 12<sup>th</sup> Class Mark sheet & Certificate for verification of date of birth.
- 5. MBBS degree certificate, MBBS 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Prof. Part 1 & II marksheets.

6. Internship Completion Certificate. MBBS Attempt Certificate.

- 7. MD/MS/DNB Marksheet, Attempt Certificate & Degree, MCI recognition certificate.
- 8. Proof of declaration of result of PG Medical Qualification (MD/MS/DM/MCh./DNB) on OR before 30<sup>th</sup> April 2025.
- 9. Character Certificate from the head of the institution from where the qualifying examination was passed.
- 10. Permanent Registration Certificate issue by NMC/State Medical Council for registration of MBBS/MD/MS qualification.
- 11. Proof of PG Medical Qualification (MD/MS/DNB) being recognized as per IMC Act/Central Government. Seat recognition letter from NMC.
- 12. Reliving order from previous institute (if working in any institute).

13. Copy of fee Receipt submitted with NBEMS.

14. Surety Bond (as per the enclosed format) of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only) on a non-judicial stamp paper of Rs. 100/- with two sureties duly attested by Notary Public. (Sureties of Resident doctors (JR/PG/SR) not allowed.) (Format is available on website, can be prepared by candidates from anywhere in India).

15. Passport size photos - two

One photocopy set of all documents (duly attested).

1. The candidates above documents will be physically verified by the Institution at the time of admission and if any discrepancy is found, the seat allotted and the admission will be cancelled.

updates regarding the counselling.
