- ELIGIBILITY FOR DENTAL SURGERY(Prosthodontics) MDS in Prosthodontics in Dental Surgery department.
- ELIGIBLITY FOR CRITICAL CARE MEDICINE MD/DNB/Diploma in Anaesthesia OR DM/DNB/Diploma in Pulmonary Medicine OR MD/DNB in Emergency Medicine OR MD/DNB in Internal Medicine OR DM/DNB in Critical Care Medicine.

They must bring original certificate/documents at the time of registration along with one set of self-attested copies of all documents in support of their candidature for the post and one recent passport size photograph & duly filled Application Form as per Annexure-I.
- 2. Undertaking in application form must be signed by the candidate.
- 3. Crucial date for determination of eligibility with reference to age, educational qualification and experience etc. will be the date of walk-in-interview.
- 4. The appointment will be initially for a period of 89 days, which could be extended for a further period of 89 days, subject to the satisfactory work & conduct report from the concerned HOD. The maximum tenure of Senior Resident will be three years including any service rendered earlier as Senior Resident on adhoc/regular basis in any Govt. of India/State Government hospital/institution.
- 5. Other service conditions will be applicable as per service conditions prescribed from time to time by the Govt. of India.

 - i. No Objection Certificate, if employed in Central Govt / State Govt / PSUs / Autonomous Bodies.
 - **Candidate must submit the latest OBC certificate issued on or after 01-04-2024 by the competent authority in the format prescribed by DOPT, Govt. of India for appointment to Central Government posts (as per Annexure-II).
