CIRCULAR

In order to regulate movement and strengthen security arrangements within the premises of **VMMC & Safdarjung Hospital**, it has been decided that **with effect from 01.01.2026**, during the period **from 6:30 PM to 5:30 AM**, the following arrangements shall be implemented:

1. Entry and Exit

Entry and exit to the hospital premises shall be permitted only through **Gate No. 5 (Sarojini Naidu Dwar)**, **Ring Road** during the above-mentioned hours.

2. Closure of Other Gates

All other gates shall remain closed for entry and exit to the hospital premises during the above-mentioned hours.

3. Traffic Circulation Plan

A Traffic Circulation Plan for regulated movement of vehicles within the hospital premises during the above-mentioned hours is **enclosed herewith** for information and strict compliance.

4. Gate No. 10 (Bhagat Singh Dwar) – SSB

Gate No. 10 shall remain open **only** for traffic movement between Factory Road and AIIMS Tunnel during the above-mentioned hours.

5. Gate No. 8 (Dr. B. C. Roy Dwar) – NOTTO/ICMR

Gate No. 8 shall continue to function as per the timings prescribed by NOTTO/ICMR.

6. Emergency Provision

In case of any exigency within the hospital premises, any gate may be opened with the direction of the competent authority, based on operational requirements.

This issues with the approval of the **Director, VMMC & Safdarjung Hospital**.

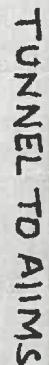
