After deliberations the matters decided upon/comments of M.S./HOD's to improve patient care services were as below:-

- HOD, Cardiology had take up the matter regarding rudeness of Group D staff with the grievance cell.
- HOD, Cardiology also informed that in order to decrease the waiting time of patient in the OPD his department has increased the number of OPD rooms from 02 (two) to 03 (three).
- It is noted that there was a large number of invalid telephone numbers that was depicted in the report and the DEO's are to be informed to be careful in filling up the mobile numbers.

 Action: CMO In-charge, OPD.
- In order to further improve staff behaviour it was suggested by the M.S. that a copy of the
 report pertaining to the department should be kept in the attendance register so that all the
 doctors, nursing staff, residents and other staff are informed of the feedback. <u>Action: All</u>
 HOD's.

- In order to increase cleanliness of toilets in the OPD, the **CMO In-charge OPD & Sanitation** were asked to improve cleanliness through BVG workers.
- It was suggested that the size of the outlet pipes of the toilets in the OPD building could be increased to improve drainage as additional funds should be available through the **Swatch Bharat Mission**.
- M.S. also noted that several toilets were locked by the staff. Only one Gents and one Ladies toilet were to be kept locked for staff. <u>Action: CMO In-charge OPD & Sanitation</u>.
- With regard to cost of treatment to patients it was again stressed that as per MCI & Ministry guidelines drug available in the dispensary should be prescribed as far as possible. Any drug written from outside should be as Generic & not as brand names.
- It was decided to audit prescription in the OPD's.
- It was stressed that all patient consent forms for procedures/surgeries should be filled and duly signed by the Doctors/Residents & Nursing staff. **Action: All HOD's**.
- It was observed that patients are inconvenienced due to shortage/non-availability of stretchers/wheel chairs. It was decided that I-Cards deposited with OPD staff that are not collected by 04:00 P.M. should be deposited with the Nodal Officer, Casualty from where the same could be collected. Boards should be made to disseminate this information to patients/relatives. Action: CMO In-charge OPD & All HOD's.
- All department Heads were requested to take up these matters with the departmental staff to improve services. <u>Action: All HOD's</u>.
- All doctors, nurses & other staff are directed to avoid unnecessary use to mobile phones for WhatsApp etc. during duty hours.

The meeting ended with a vote of thanks.
