- The Chairperson sought a reply from the HOD-CARDIOLOGY regarding the performance for the month of May vis a vis for the month of April, 2017. The HOD-CARDIOLOGY submitted that he would sensitize the departmental staff further with reference to the subject matters depicted in the report. He also said that in the past month some punitive action has been taken against staff whose performance was found to below expectations.
- Dr. R. Dewan who represented the HOD OBS & GYNAE has informed that in view of last
 month report the department in the ANC OPD have segregated the patients into high risk
 and low risk and started making separate Q's, so that, patient care services of the high risk
 patients are facilitated to ensure lesser waiting time. The doctors have been directed report
 to the OPD on time. The Sisters In-charge of the OPD's has been directed to ensure
 cleanliness. All residents of the department have also been sensitized to ensure that
 behaviour with patients is better and that only formulary drugs are prescribed to patients.
- CMO In-charge OPD was directed to ensure that cleanliness of the OPD premises is improved upon.
- HOD's desired that the DNS be called to the meeting from next month to ensure improved cleanliness in the hospital premises.
- HOD-NEURO SURGERY has suggested that a public relation officer be available to discuss
 patient care related issues with the relatives of patients.

- The Medical Social Welfare Department was requested to ensure sufficient Wheel Chair & trolleys were available for disabled/sick patients to enable smooth mobility in the OPD/hospital.
- All HOD's were intimated by the Chairperson that a written report in reference to the departmental performance for the month of May compared to April be sent to the Office of Addl. M.S. within 07 days (Friday 23rd June, 2017) so that further action in this regard could be initiated.
- Memorandum to HOD's who were not present for the meeting are to be issued a memorandum & the same would be entered in the personal files for ignoring official directions.

The meeting ended with a vote of thanks to the Chair.
