Tenderer who has downloaded the tender form from the website <u>www.vmmc-sjh.nic.in</u> and/or Central Public Procurement Portal (CPPP) website https://eprocure.gov.in/eprocure/app, https://eprocure.gov.in/epublish/app shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be

tempered/modified in any manner, tender will be rejected and EMD will be forfeited and tenderer would liable to be banned from doing business with Safdarjung hospital.

- 5. Intending tenderers are advised to visit again on the website <u>www.vmmc-sjh.nic.in</u> and CPPP website <u>https://eprocure.gov.in/eprocure/app</u> at least 2 days prior to closing date of submission of tender for any corrigendum / addendum/ amendment.
- 6. The **Hard Copy** in respect of (i) Earnest Money, (ii) original copy of Affidavits, must be dropped into the Tender Box kept in MS office block, Safdarjung Hospital, New Delhi on or before bid opening date/time as mentioned in critical date sheet.
- 7. **Modification and Withdrawal of Bids**. Bidders may modify or withdraw his online bid after submission as per the facility provided in the CPP Portal, only prior to the date and time prescribed for end of submission of Bid.No bid shall be modified after the date and time for end of submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of bid validity specified. Withdrawal of a bid during this period will result in bidder's forfeiture of Earnest Deposit (EMD).
