4. **Tenderer/Contractor are advised to follow the instructions provided in the ‘Tender documents to the Contractors/Tenderer for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>**
5. **Tenderer who has downloaded the tender from the website www.vmmc-sjh.nic.in and Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the tender form including downloaded price bid template in any manner.** In case if the same is found to be tempered/modified in any manner, tender will be rejected

and EMD will be forfeited and tenderer would liable to be banned from doing business with Safdarjung hospital.

6. Intending tenderers are advised to visit again on the website www.vmmc-sjh.nic.in and CPPP website <https://eprocure.gov.in/eprocure/app> at least 2 days prior to closing date of submission of tender for any corrigendum / addendum/ amendment.
7. The **Hard Copy** in respect of, (i) Earnest Money, (ii) original copy of Affidavits, must be dropped into the Tender Box kept in MS office block, Safdarjung Hospital, New Delhi **on or before bid opening date/time as mentioned in critical date sheet.**
8. **Modification and Withdrawal of Bids.** Bidders may modify or withdraw his online bid after submission as per the facility provided in the CPP Portal, only prior to the date and time prescribed for end of submission of bid. No bid shall be modified after the date and time for end of submission of bids. No bid may be withdrawn in the interval between the deadline for submission of bids and expiry of the period of bid validity specified. Withdrawal of a bid during this period will result in bidder's forfeiture of Earnest Deposit (EMD).
9. One bidder is permitted to submit only one bid. Failure to comply this will lead to rejection of all the bids by that bidder.
10. In the event of any of the above mentioned dates being declared as holiday, the Tender will be opened on the next working day at the appointed time.
