- 1. Age relaxation for SC/ST/OBC/PWD and experienced candidates will be as per the rules.
- 2. - 3. Shortlisted candidates will be informed via email or phone for the online interview.
- 4. The result will be declared and displayed on the website/Notice board in VMMC &SJH.
- 5. Candidates have to submit the duly self-attested documents with Mobile Number.
- 6. Selected candidates have to bring all the original documents mentioned above in the original for verification at the time of joining.

Terms and Conditions:

- 1. The above position is on a temporary contract basis.
- 2. The Appointing Authority has the right to accept/reject any application without assigning any reason (s) and no correspondence in this matter will be entertained.
- 3. The appointment can be terminated with one month's notice from either side without assigning any reason.
