The terms and conditions for appointment of contract basis: -

1. Remuneration of Rs. 1,23,500/- (Rupees One Lakh Twenty Three Thousand Five Hundred Only) per month (consolidated), 2nd year Rs. 1,30,000/- (Rupees One Lakh Thirty Thousand Only) per month (consolidated). The contractual appointee will not be entitled to any allowances, financial benefits or concessions as admissible to Govt. employees. Income Tax will be deducted at source on monthly basis
2. **Age of Candidates should not be more than 40 years for Assistant Professor on the date of interview. Relaxation as per rules of Central Govt.**
3. The contractual employment will be for a period of one year or till the regular candidates join, whichever is earlier. The services of the appointee are also terminable before expiry of the contractual period by either side after giving 30 days' notice or salary in lieu thereof. The selection is purely contractual in nature and does not confer any right for regularization or permanent absorption.
