#### Chapter-3 TENTATIVE SCOPE OF WORK OF EOI

- I. The proposed CCTV network is intended to extend the surveillance of the VMMC & Safdarjung Hospital based CCTV surveillance facility for monitoring at VMMC & Safdarjung Hospital. The surveillance network will be augmented in phases with the addition of new places of interest under surveillance. Currently there are about 413 Nos. Analog and 366 Nos. Digital CCTV cameras installed in different areas of the campus and these are to be integrated with the new proposed CCTV surveillance system.
- II. The proposed system shall be based on non-proprietary open standard (ONVIF) based integrated solution with network centric functional and management architecture. The total number of cameras required **3000** Nos **approx**.
- III. The bidders shortlisted through the EoI will assist in setting up an integrated security surveillance system which would involve the design, supply, installation, testing, commissioning and 24/7 operations/maintenance for at least 5-years of an effective and state-of-art IP-based integrated CCTV security and surveillance system in the campus.
- IV. Scope of work includes survey, design, site preparation, supply, installation, testing, training, along with operations and maintenance of physical and IT Infrastructure for CCTV based Surveillance System across multiple sites spread across the campus as per the following:
  - i. Detailed Site Survey of the desired areas of surveillance.
  - ii. Preparation and submission of Site Survey Reports.
  - iii. Preparation and submission of detailed solution document and network architecture including but not limited to the following components:
    - a) PoE based IP CCTV Cameras having at least 4 MP or higher resolution and vandal resistant IP 65/IP 66 environmental protection. The cameras can be fixed (bullet/dome type), PTZ depending on the site requirement in different locations of the Institute as listed in the next section. The range of operation and operating condition will depend on the site conditions to provide a clear image of Full HD quality even in very low ambient light condition.
    - b) Dedicated (separate VLAN) CCTV Network is to be planned in the campus. This has to be realized using active network with necessary Layer 2/Layer 3 switches and passive network with UTP CAT6/7 cables on the optical fibre backbone.
    - C) Identifying the correct camera location, mounting arrangement, networking and power supply arrangement from the nearest designated ports at each location along with appropriate camera types as may be suitable for the site requirement.
    - d) Provision of monitoring the cameras signals in the central control room as well as localized monitoring at various department/ building levels. The monitoring location of each group of cameras will be provided by the Institute.
    - e) Control room setup for a cluster of cameras with recording and monitoring in a distributed architecture for the total surveillance system.
    - f) Suggestive (non-essential), Additional Items should be mentioned in bill of material with clear indication of "#" before name of item.

## **Functional Requirement of the Project:**

The suggested system should have the following salient features:

- A. Day & Night online surveillance of the identified critical locations/busy public places on a 24x7x365 days basis.
- B. The cameras should consist of a combination of fixed and PTZ with Full HD or better quality in Day & Night Vision with good low light performance.
- C. The monitoring of cameras should be on real time basis in a central control room with possibility of localized monitoring at various department/ building levels.

- L. The system should be scalable and possibility to add 3rd party IP cameras, monitoring stations, storage systems or other devices at a later stage.
- M. Protection of outdoor cameras from harsh environmental conditions like heat, dust, and heavy shower.
- N. Operation and maintenance manpower should be planned for a period of 5 years.
- O. On-site warranty and Post-Warranty Maintenance and spare parts support of all hardware, software and accessories.
- P. On-site service personnel shall be available during the warranty & post warranty. This includes the existing CCTV surveillance systems of the Institute.
