Instruction for Document Verification

1. Visit <https://hll.cbtextam.in/> for downloading the document verification admit card

You are also requested to bring the following: -

a) Original certificates/marks sheets starting from class 10th onwards mentioned in your application in support of your qualification, age caste/ category, experience etc alongwith copy of application form.

b) Four copies of recent passport size photographs along with admit card issued by HLL for computer-based test (CBT).

c) Multiple set of self-attested photocopies of all the certificates/mark sheets starting from class 10th onwards, as per (a) above.

d) Caste certificate (in original) in the prescribed proforma from the Distt.

Magistrate/Deputy Commissioner/Collector of your district or any authority empowered for the purpose. Caste certificate of OBC (NCL) & EWS issued by the Competent Authority should be in the prescribed proforma for applying for appointment to posts under the Government of India for the financial year 2022-23 issued on or after 01.04.2023.

e) For candidates seeking age relaxation in view of working as central government employee, the candidates are requested to bring the requisite service certificate/experience certificate and N.O.C. from the concerned organization.

f) A duly filled form for document verification, along with their preferred hospital ranks mentioned (if applicable for the concerned post)

2. If any of the particulars stated by you in the application, is on verification, found incomplete or wrong, or if you are found to have willfully suppressed material information relevant to the consideration of your case without prejudice to any other action that may be taken in consequences thereof, your candidature will summarily be rejected and you will not be considered for appointment to the post.

3. No TA/DA will be paid to you for attending the verification.
4. SJH, LHMC, RML, KSCH & RHTC reserves the right to postpone or deferring the dates of verification for which due intimation will be sent to you/uploaded on SJH, LHMC, RML, KSCH & RHTC website. In this event no claim will be entertained against the cancellation charges of tickets or otherwise by SJH, LHMC, RML, KSCH & RHTC. Also, a candidate scheduled for the verification on a date may have to overstay by not more than one day for which he/she should make arrangements at his/her own expenses.
