## Sub: Revocation of Visas of Pakistani nationals - regarding

The undersigned is directed to refer to this Ministry's Office Memorandum of even number dated 24.04.2025, regarding revocation of SAARC Visa for Pakistani nationals.

2. In continuation of the above order and in exercise of the powers under Section 3(1) of the Foreigners Act, 1946, the Government has decided to suspend the Visa services to Pakistani nationals with immediate effect. All existing valid Visas, except Medical visas, Long Term Visas, Diplomatic & Official visas, issued by Government of India to Pakistani nationals stands revoked with immediate effect from 27<sup>th</sup> April 2025. Medical Visa issued to Pakistani nationals will be valid only till 29<sup>th</sup> April 2025. No new visas will also be issued in this regard. This order will not apply to Long Term Visas (LTVs) and Diplomatic & Official Visas issued to Pakistani nationals is given at Annexure.

3. Ministry of External Affairs and Bureau of Immigration are requested to give wide publicity of this Order suitably through their website and take appropriate necessary action for compliance of the order.
