

## New Delhi, the 19th February, 1996

G.S.R. 120.—In exercise of the powers confered by the proviso to article 309 of the constitution and in supersession of the—

- (i) Sufdarjang Hospital (Class III posts) Recruitment Rules, 1973, in so far as they relate to the post of Assistant Matron:
- (ii) Willingdon Hospital and Nursing Home (Class III posts) Recruitment Rules, 1973, in so far as they relate to the post of Assistant Matron;
- (iii) Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital, New Delhi (Group 'C' posts) Recruitment Rules, 1981, in so far as they relate to the post of Assistant Nursing Superintendent;
- (iv) Kalawati Saran Children's Hospital, New Delhi, (Group 'C' posts) Recruitment Rules, 1981, in so far as they relate to the post of Assistant Nursing Superintendent;
- (v) Jawaharlal Institute of Post-Graduate Medical and Research, Pondicherry (Class III posts) Recruitment Rules, 1975, in so far as they relate to the post of Assistant Nursing Superintendent;
- (vi) Hospital for Mental Diseases, Ranchi, (Recruitment to Class III and Class IV posts) Rules, 1959, in so far as they relate to the post of Assistant Nursing Superintendent, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Nursing Superintendent in Safdariang Hospital Dr. Ram Manohar Lohia Hospital Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital Kalawati Saran Children's Hospital Jawaharlal Institute of Post Graduate Medical Education & Research, Pondicherry, Central Institute of Psychiatry, Ranchi, namely :-

- 1. Short title and commencement.—(1) These rules may be called the Safdarjang Hospital Dr. Ram Manchar Lohia Hospital Lady Hardinge Medical College & Smt. S. K. Hospital Kalawati Saran Children's Hospital Jawaharlal Institute of Post Graduate Medical Education and Research, Pondicherry Central Institute of Psychiatry. Ranchi, (Assistant Nursing Superintendent) Recruitment Rules, 1996.
- 2. Number of post, classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualification etc.—The method of the recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 14 of the said Schedule.
  - 4. Disqualification.—No person.
    - (a) who has entered into or contracted a marriage with a person having a spouse living, or
    - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders, issued by the Central Government from time to time in this regard.

## पर्यावरण और वन मंत्रालय नई दिल्ली, 12 फरवरी, 1996

सा.का.नि. 121-राष्ट्रपति, संविधान के धनुच्छेद 309 के परन्तुक द्वारा प्रवत्त शक्तियों का प्रयोग करते हुए, बन शिक्षा, निवेशालय, देहरादून के कार्यालय, राज्य वन सेंबा महाविद्यालय, कोयम्बट्टर तथा बरनिहाट और पूर्वोत्तर रेंजन महाविद्यालय कुर्मिम्नांग में कतिपय ममूह "ख" पदों पर भर्ती की पद्धित का विनियमन करने के निये निम्नलिखित नियम बनाते हैं, धर्षात् :—

- 1. संक्षिप्त नाम और प्रारम्भ: (1) इन नियमों का संक्षिप्त नाम वन शिक्षा निदेशालय और इसके घटक महाविद्यालय (समूह "ख" पद) भर्ती नियम, 1996 है।
  - (2) ये राजपत्र के प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. पद-संख्या, वर्गीकरण और बेतनमान : उक्त पदों की संख्या, उनका वर्गीकरण और उनके वेतनमान वे होंगे, जो इन नियमों से उपाबद्ध श्रनुसूची के स्तम्भ (2) सें स्तम्भ (4) में विनिद्धिष्ट हैं।
- 3. भर्ती की पद्धति, श्रायु-सीमा और श्रन्य ग्रहेंताएं: उक्त पद्धों पर भर्ती की पद्धति, श्रायु-सीमा, श्रहेंताएं और उनसे संबंधित श्रन्य बातें वे होंगी जो उक्त श्रनुसूची के स्तम्भ (5) से स्तम्भ (14) में विनिविष्ट हैं।
  - 4. निरईता : वह व्यक्त---
  - (क) जिसने ऐसे व्यक्ति से जिसका पति या जिसकी पत्नी जीवित है, विवाह किया है; या
- (ख) जिसने श्रपने पति या श्रपनी पत्नी के जीवित होते हुए किसी व्यक्ति से विवाह किया है; उक्त पदों पर नियुक्ति का पाझ नहीं होगा:

परन्तु यर्दि केन्द्रीय सरकार का यह समाधान हो जाता है कि ऐसा विवाह ऐसे व्यक्ति और विवाह के भ्रन्य पक्षकार को लागू स्वीय विधि के ग्रधीन भ्रनुज्ञेय है और ऐसा करने के लिये भ्रन्य श्राधार हैं तो वह किसी व्यक्ति को इस नियम के प्रवर्तन में छूट दे सकेगी।

- 5. शिथिल करने की शक्ति: जहां केन्द्रीय मरकार की यह राय है कि ऐसा करना श्रावश्यक या समीचीन है, वहां वह उसके लिये जो कारण हैं उन्हें लेखबढ़ करके तथा संघ लोक सेवा श्रायोग सेपरामर्श करके, इन नियमों के किसी उपबन्ध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, श्रादेश द्वारा शिथिल कर सकेगी।
- 6. व्यावृत्तिः इन नियमों की कोई बात, ऐसे ग्रारक्षण, श्रायु-सीमा में छूट और श्रन्य रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर निकाले गये आदेशों के श्रनुसार श्रनुसूचित जातियों, श्रनुसूचित जनजातियों, भृतपूर्व सैनिकों और ग्रन्य विशेष प्रवर्ग के व्यक्तियों के लिये उपबन्ध करना धपेक्षित है । 449 GI/96—5.
