- G.S.R. 44.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Preside hereby makes the following rules regulating the method of recruitment to the post of Stenographer Grade I in the Safdarju-Hospital, New Delhi, namely :-
- 1. Short title and commencement.—(1) These rules may be called the Safdarjung Hospital (Stenographer Grade Group 'B' Post, Recruitment Rules, 2004.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and scale of pay:—The number of the said post, its classification and the sea of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of Recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications at other matters relating to the said post shall be as specified in columns 5 to 14 of the said Schedule.
 - 4. Disqualification.—No person.—
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal la applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt as person from the operation of this rule.

- 5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do. may, by order, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax at of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.—Nothing in these rules shall affect reservation, relaxation of age limit and other concession required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories persons in accordance with the orders issued by the Central Government from time to time in this regard.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists, shall not be eligible for consideration for appointment by promotion. (The Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.)
