टिप्पण : पृष्ठ से संबंधित विभागीय प्रोन्नति समिति की कार्यवाहियों, संघ लोक सेवा आयोग के अनुमोदनात्मक नहीं होगी। किन्तु, यदि 'आयोग' उनका अनुमोदन नहीं करता है तो विभागीय प्रोन्नति समिति की बैठक संघ लोक सेवा आयोग के अध्यक्ष या किसी सदस्य की अध्यक्षता में फिर से होगी।

New Delhi, the 21st September, 1990

G.S.R. 636.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Workshop Manager (Training) in the Safdarjang Hospital, New Delhi, namely:—

1. Short title and commencement.—(1) These rules may be called the Safdarjang Hospital, New Delhi, Workshop Manager (Training) Recruitment Rules, 1990.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. Number of post, classification and scale of pay.—The number of said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
3. Method of recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns 5 to 14 of the said Schedule.
4. Disqualification.—No person,—
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.—Nothing in these rules shall affect relaxations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

1. Diploma in Mechanical/Electrical Engineering or a diploma/equivalent certificate in Prosthetic and Orthotic of a recognised University Institution or equivalent.

2. 5 years' experience in the manufacture/fitting of Prosthetic and Orthotic appliances including experience in workshop management, teaching and conducting training courses for Prosthetists and Orthotists.

Note : 1. Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

Note : 2. The qualification(s) regarding experience is/are relaxable at the discretion of the Union Public Service Commission in the case of candidates belonging to Scheduled Castes and Scheduled Tribes, if, at any stage of selection, the Union Public Service Commission is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

Note: The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul & Spiti district and Pangi Sub-Division of Chamba district of Himachal Pradesh, the Andaman and Nicobar Islands or Lakshadweep).
