iii)	When called upon by the Government at any time within a period of Six Months from the receipt of the notice as aforesaid join the Central Health Services/State Medical Services and serve in rural area anywhere in the state for a minimum period of Two Years at such remuneration as may be prescribed before and in the event the student being
