NOTICE

Sub: Instructions for candidates who are joining PG courses (MD/MS) 2021-22 session.

All postgraduate students who have been allotted various PG courses in this institution under 50% All India Quota/50% University State Quota by MCC, DGHS, have to bring following original documents with 2 self attested photocopies for the admission. These documents will be physically verified by the Institute and will be kept with the Institution till the completion of tenure of course.

The following original documents are required for the admission in PG courses:

- 1. 10th & 12th class Certificate for verification of date of birth
- 2. Certificate in support of educational qualification: M.B.B.S. Degree
- 3. Detailed marks certificate of qualifying examinations: I, II & Final Professional examination of M.B.B.S.
- 4. The Compulsory rotating internship certificate till 30.09.2021
- 5. Registration Certificate from Delhi Medical Council / State Medical Council / Medical Council of India
- 6. SC/ST Certificate issued by the competent authority (in the format as specified in the prospectus) in English or Hindi language. Sub caste should be clearly mentioned in the certificate.
- 7. OBC certificate issued by the competent authority. The Sub-caste should tally with the Central List of OBC. The OBC candidates should not belong of Creamy Layer. The OBC certificate must be in the prescribed format as mentioned in the prospectus only and applicable for the year 2021-22.
- 8. Orthopaedic Physical Disability (Physically Handicapped) Certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Persons with Disability Act, 2016. (Prescribed format as mentioned in the prospectus). No other PwD Certificate, issued by any other Authorities/Hospital will be entertained.
- 9. Seat Allotment Letter issued by MCC
- 10. Admit Card issued by NBE in original
- 11. "NEET" Score Card
- 12. Character Certificate from the head of the institution from where the qualifying examination was passed
- 13. Employer's certificate and a No Objection Certificate (NOC), if employed



- 14. Copy of fee submission receipt along with transaction ID and date.

 A total fee amount of Rs.44000/- {Rs.33000/--Tuition fees (College Share+ University Share) + Rs.1000/- (Student activity fee) + Rs.10000/- (Security Deposit-refundable)} to be deposited through online fees payment link given in VMMC website www.vmmc-sih.nic.in at Students Zone. After fee deposition, students have to take print out of receipt and also upload and update the fee details through Google form via link; https://forms.gle/1bpAuNkqosbyqLW39.
- 15. Surety Bond (as per the enclosed format) of Rs.3, 00,000/- (Three lacs) on a non-judicial stamp paper of Rs.100/- with two sureties duly attested by Notary Public. (Sureties of Resident doctors (JR/PG/SR) not allowed.) (Format is available on website, can be prepared by candidates from anywhere in India)
- 16. Certificate of Solvency duly signed by Gazetted Officer in the enclosed format. This can be prepared by candidates from anywhere in India.
- 17. Medical examination will be done before the commencement of session. (Two passport size photograph is needed for the same)
- 18. Passport Size Photos-6
- 19. Photo Identity Proof (Aadhar Card/PAN Card/Driving License)

If any student is unable to come physically in view of current pandemic situation, he should <u>scan</u> the <u>original documents</u> as listed above after converting all documents in a single pdf file and upload them to the <u>following e-mail id</u> after depositing the fees online. Such candidates should also submit their willingness for participation in further round of counseling.

<u>Note:</u> The candidate and these documents will be physically verified by the Institution at the time of admission, and if any discrepancy is found, the seat allotted and the admission will be cancelled.

- > The fees should be deposited online and the transaction ID will be submitted to this Institute.
- > Candidates should be prepared to stay one or two days as no. of admissions in a day will have to be staggered for following Covid protocol.
- > To maintain covid protocol, the days have been decided for candidates reporting according to the department/program wise for convenience of the candidates. (as per the enclosed schedule)
- For 1st Round of Counseling, reporting at the Institute will be from 23/01/2022 to 28/01/2022. 23/01/2022 (Sunday) will be a working day. There will be no Counseling on 26/01/2022 due to travel restrictions in Delhi in view of Republic Day Parade. The last date of reporting at Institute for 1st Round of Counselling is 28th January, 2022 as per server time.



- ➤ All PG Courses session (Physical Joining) will start from 01/02/2022 as per NMC notification. All the students who report for admission must join their duties physically from 01/02/2022. Medical examination will be done before the commencement of session. For medical examination, the candidates must report in the morning hours.
- ➤ Candidates have to follow Covid Protocol guidelines properly. Further, students are advised to visit MCC, NMC, GGSIP University and Institute website regularly for updates regarding the Counselling.
- ➤ Only the candidate will be allowed in the Counselling Room. Candidates have to report for admission at Counselling Room near Principal Office, Ground Floor, VMMC College Building, VMMC & Safdarjung Hospital. Time for Reporting: 10.00 AM
