- 1. Seat Allotment letter issued by MCC
- 2. 10th & 12th Class Certificates for verification of date of birth
- 3. Certificate in support of educational qualification: M.B.B.S.Degree & MD/MS Degree / DNB Degree
- 4. Detailed marks certificate of qualifying examinations: I, II & Final Professional examination of M.B.B.S & MD/MS Mark sheets
- 5. The Compulsory rotatory internship completion certificate
- 6. Registration Certificate from Delhi Medical Council / State Medical Council / Medical Council of India
- 7. MD/MS/DNB Examination attempt Certificate and MCI Recognition certificate
- 8. Proof of writing thesis in case of candidate has passed DNB course
- 9. Character Certificate from the head of the institution from where the qualifying examination was passed
- 10. Employer's certificate and a No Objection Certificate (NOC), if employed. Students must bring Relieving order from employer within the stipulated time period for physical joining the course
- 11. Admit Card issued by NBE in original
- 12. Rank letter/ NEET Score card issued by NBE in original
