With reference to advertisement notice no RECTT-2/1/2023-Recruitment Cell/1 dated: 25.09.2023 published on the website of VMMC & Safdarjung Hospital (www.vmmc-sjh.nic.in), in Rozgar Samachar (Hindi) and Employment News (English) in 21-27 October 2023 and corrigendum no. **F. No. RECTT-2/1/2023-Recruitment Cell** dated 30.10.2023, the following amendments are made: -

**1.)** The age limit for S. No. 3 of table having details of posts i.e., Occupational Therapist:-

### May be read as: 21-30 years

#### Instead of: 21-28 years

**2.)** In essential qualification column for S.No. 3 of table for the post of Occupational Therapist of the advertisement notice as mentioned above-

# The essential qualification is to be read as -

(i) Bachelors degree in Occupational Therapy of minimum four years duration from a recognised University or Institute; and

(ii) One year experience as Occupational Therapy in a recognised institute or hospital.

#### <u>OR</u>

(i) Diploma in Occupational Therapy of minimum two years duration from a recognised University or Institute; and

(ii) Three years experience as Occupational Therapist in a recognised Hospital or Institute.

# **INSTEAD OF**

(i) Bachelors degree in Occupational Therapy from a recognized University or Institute; and

(ii) Two year experience as Occupational Therapist in a govt. hospital or institute.

# 

i) 12th class pass with Science (Physics, Chemistry, Biology) from a recognised board or institute

ii) Diploma of two years duration in Occupational Therapy from a

recognized University or Institute

iii) Three years experience as Occupational Therapist in a recognized Hospital or Institute

3.) In case candidates who have already applied for the post of Occupational Therapist wish to re-submit the application for the post mentioned above, they may do so as per schedule. The candidates will not be required to re-submit the fee in this case and they may submit the fresh application with the receipt of fee payment, copy of demand draft or any other relevant mode of payment they had made while applying earlier.

**4.)** It is further intimated that in case VMMC & Safdarjung Hospital receives more than one application by a candidate for the same post, only the latest application received will be considered.

**5.)** Rest of the content remains unaltered.
